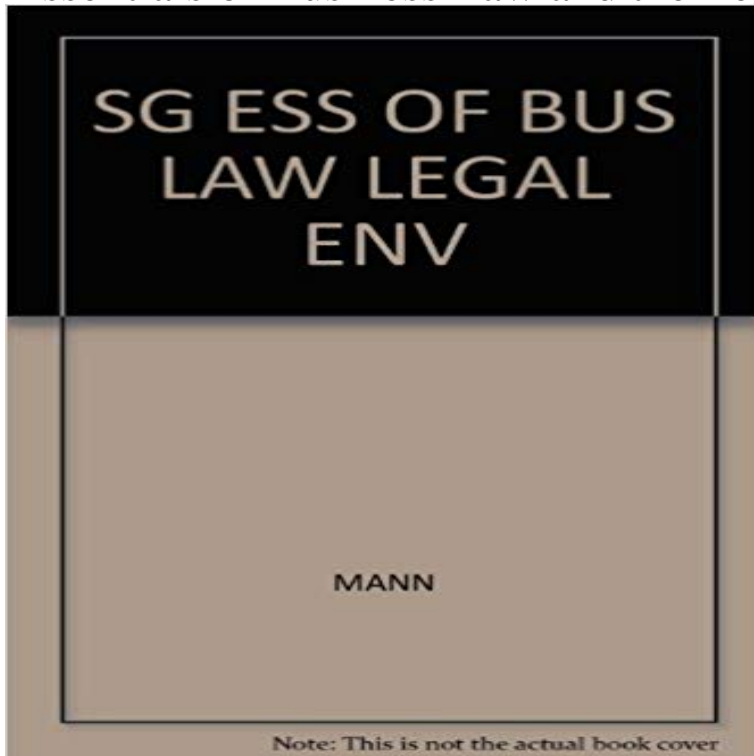


Essentials of Business Law and the Legal Environment
