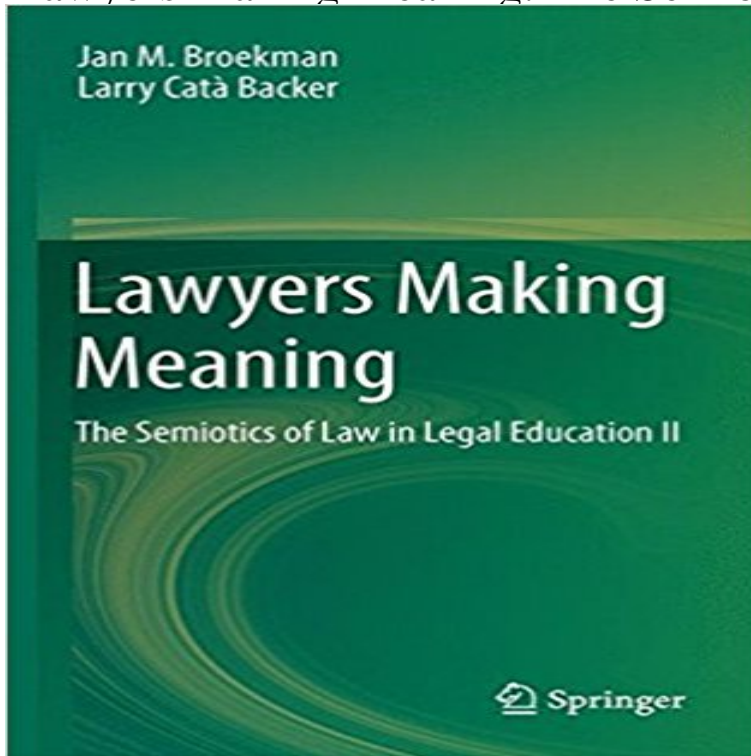


Lawyers Making Meaning: The Semiotics of Law in Legal Education II
