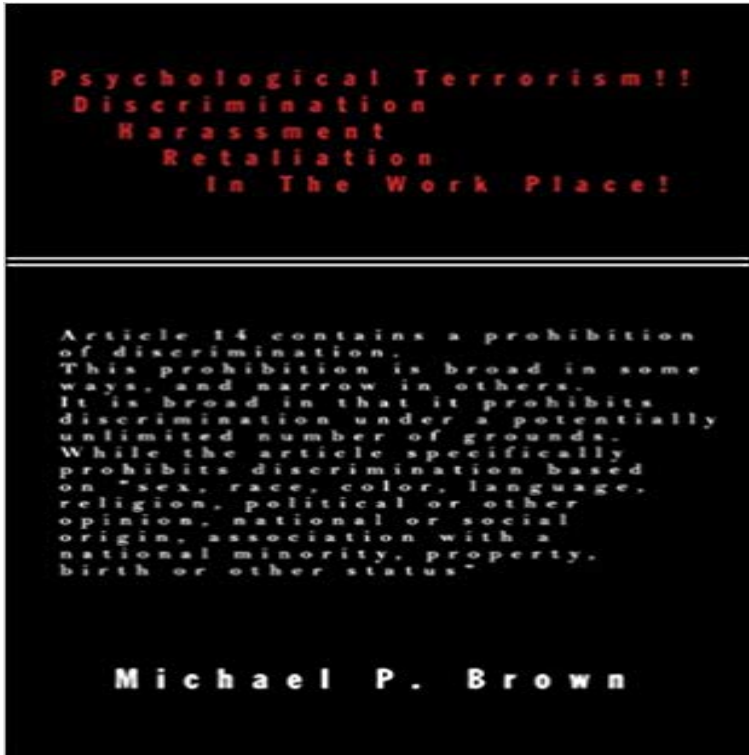


# Psychological Terrorism!!: Discrimination Harassment Retaliation In The Work Place!
