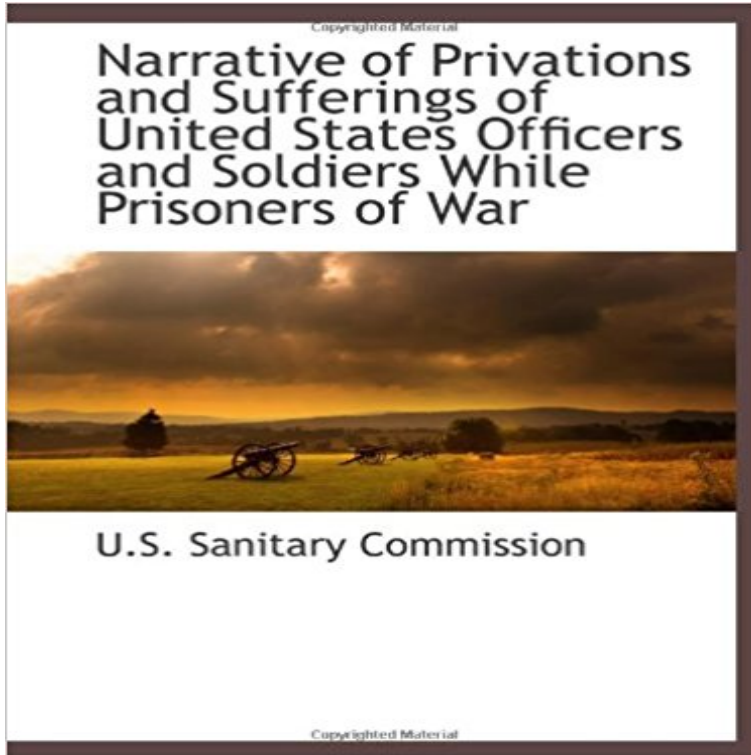


# Narrative of Privations and Sufferings of United States Officers and Soldiers While Prisoners of War
